We look forward to &#127819; a future where players globally have more choice to play their favorite games. &lt;/p>  
&lt;p>In the United States, the FTC had argued &#127819; the acquisition deal would hurt consumers whether they played video games on consoles or had subscriptions because Microsoft would have &#127819; an incentive to shut out rivals like Sony Group.&lt;/p>  
&lt;p>However, Judge Jacqueline Scott Corley ruled on 11 June: The FTC has &#127819; not shown it is likely to succeed on its assertion the combined firm will probably pull Call of Duty from &#127819; Sony PlayStation, or that its ownership of Activision content will substantially lessen competition in the video game library subscription and &#127819; cloud gaming markets. &lt;/p>  
&lt;p>To address the FTC s concerns, Microsoft had agreed to license Call of Duty to rivals, including a 10-year &#127819; contract with Nintendo, contingent on the merger closing.&lt;/p>  
&lt;p>On Sunday, Microsoft did not disclose the duration of the agreement with Sony.&lt;/p>
